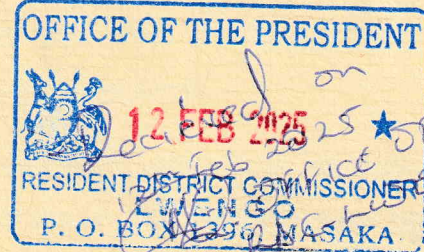

refers; we address you as hereunder;

Lwengo District NGO Forum is a duly incorporated name with a trade mark sign  
registered in accordance of the laws of Uganda.

It is information from our client that Lwengo District NGO Forum registered its trade  
mark as LDNGOF and as a result was issued with the certificate of registration. A  
copy is hereto attached.

Additionally it is information from our client that she later applied to the National  
Bureau of Non-Governmental Organizations where upon fulfilment of the  
necessary requirements was subsequently issued with the Certificate of  
Registration and the Permit of registration under the name Lwengo District NGO  
Forum.

Our client further informs us that, it has become your practise through numerous  
documentations to repeatedly allude to the fact that LDNF is as same as Lwengo  
District NGO Forum which is completely false.

Furthermore, you have continuously misled the office of the Attorney General  
where in his letter dated February 4<sup>th</sup>, 2025 he specifically quoted your letters  
dated 6<sup>th</sup> January 2025 and 9<sup>th</sup> January 2025 where he categorically said that you

Failure of which, we have instructions from our client to institute both civil and criminal proceedings against you personally at your own costs and peril.
