RE: COMPLAINT AGAINST MR. KYAGELA IDDI, ASSISTANT TOWN CLERK, KYAZANGA TOWN COUNCIL, FOR ALLEGED IMPERSONATION, FRAUDULENT ACCESS TO PARISH DEVELOPMENT MODEL (PDM) FUNDS, ABUSE OF OFFICE AND RELATED IRREGULARITIES.

We, write to your office in our capacity as Volunteer Uganda Extra Limited, a duly incorporated body under the laws of Uganda operating within Uganda with the mandate of **fighting corruption, Protection of human rights, ensuring transparency and accountability of public funds, legal protection and the rule of laws**

Our organization has consistently worked with communities and government stakeholders in promoting integrity, accountability and effective service delivery. In recognition of our contribution towards the promotion of good governance, the rule of law and the fight against corruption, Volunteer Uganda Extra Limited was **awarded a Certificate of Appreciation by the Lwengo District Local Government Council on 27th June 2024.**

It is pursuant to the foregoing mandate and our commitment to protecting public resources that we bring to your attention serious allegations concerning **Mr. Kyagela Iddi**, the Assistant Town Clerk of Kyazanga Town Council and who is also reportedly serving as a Town Agent in Kyazanga Central Ward. The allegations raise concerns of possible impersonation, fraudulent acquisition of Parish Development Model (PDM)

funds, abuse of office, conflict of interest and unethical conduct warranting urgent investigation by your office.

PARTICULARS OF THE COMPLAINT

1. That Mr. Kyagela Iddi is alleged to have impersonated approximately four (4) individuals and fraudulently secured UGX 1,000,000/= from three purported beneficiaries under the Parish Development Model (PDM).
2. That he is alleged to have used the National Identification Number CM8810510083IL belonging to Richard Ndawula, a resident of Lwengo Town Council, together with the identity of Nakitende Eseza, Telephone No. 0749907881, a resident of Kyazanga Central, Lwela Village, and thereby obtained UGX 1,000,000/= under the guise of membership in Beans Enterprise Group, whose Chairperson is Asimwe Alex.

Our Preliminary findings further reveal that the account through which the said funds were processed was created on 14th July 2025, and that the alleged PDM funds amounting to UgX. 1,000,000/- were received on 17th July 2025 through her (Eseza's) registered telephone Number 0749907881, which warrant thorough investigation into the authenticity and propriety of the transaction.

3. That the same individual is further alleged to have accessed PDM funds through the identities and National Identification particulars of:

a. Nabasiye Kate, Industrial Zone, Central Ward, Lwengo Town Council a headteacher in a public primary school and therefor a public servant. It is our understanding that public officers are generally not intended beneficiaries of the Parish Development Model (PDM); and

b. Nambejja Justine, Lwengo Town Council/Lwengo Sub-county, Lwengo District.

4. That if these allegations are established, the same would amount to fraudulent use of personal information and unlawful acquisition of government funds intended for genuine beneficiaries.
5. That it is further questionable how the said officer could simultaneously hold the offices of Assistant Town Clerk and Town Agent, a matter which raises concerns regarding conflict of interest, abuse of authority and adherence to public service ethical standards.
6. That it is equally concerning that the said officer, who is reportedly resident and deployed in a different Town Council, could access and utilize personal information of individuals from different localities for purposes of obtaining PDM funds.



That the above actions, if proved, undermine public confidence in government poverty alleviation programmes and may occasion loss of public funds.

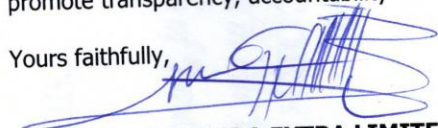
PRAYERS

In the circumstances, we request your office to:

- a) Institute an immediate and independent investigation into the allegations against Mr. Kyagela Iddi;
- b) Audit and verify all PDM beneficiary records connected to the above-mentioned persons;
- c) Establish whether any public funds were fraudulently obtained through impersonation or misuse of personal information;
- d) Investigate the legality and propriety of the said officer simultaneously serving as Assistant Town Clerk and Town Agent;
- e) Cause recovery of any misappropriated public funds and recommend appropriate disciplinary, civil or criminal proceedings against any persons found culpable; and
- f) Inform our organization of the outcome of the investigations and the action taken.

We submit this complaint in the public interest and in furtherance of our mandate to promote transparency, accountability and the rule of law within our communities.
